

# **CERTI Advisory Council**

have had the pleasure of collaborating with faculty from Chesapeake Bay Academy (CBA) for over four years now. In the summer of 2017, I conducted my pilot research at Old Dominion University (ODU). Several students from CBA were participants in my study and I remember Dr. Jankowski and Dr. Ball coming to the ODU pool to watch our students test the underwater rovers that they designed. The fact that Dr. J and Dr. Ball took time out of their busy schedules to drive to ODU and spend several hours with their students and me, spoke volumes about their commitment to education and CBA.

I conducted my dissertation research at CBA as well, from November 2018 to March 2019. Again, I received much support from Dr. J and the CBA faculty. Then, I was invited to join the Education and Research Committee and gladly accepted the invitation. It was through conversations around research with Dr. J and Dr. Ball that the Center for Education Research and Technology Innovation (CERTI) was created.

The CERTI Advisory Council is comprised of professionals who bring their diverse areas of expertise to each project. Members include Dr. J and Dr. Ball, Dr. Mary Roberts, Associate Professor, Art Therapy and Counseling, Eastern Virginia Medical School, Dr. Taryn Myers, Director of Academic Effectiveness and Associate Professor of Psychology, Virginia Wesleyan University, and myself, Dr. Mindy Gumpert, Adjunct Assistant Professor, Virginia Wesleyan University and Old Dominion University.

Our first CERTI initiative was to document the years of innovative technology utilized by CBA students to help create a roadmap for future projects. Our second CERTI task was to apply for an E.E. Ford Educational Leadership Grant. The grant application took four months to complete. Weekly meetings gave the team time to get to know each other, which was an added bonus. Notably, incorporating the ideas of five strong-willed, creative professionals into a two-page document was a monumental task! Currently, the CERTI team is working on a submission to the Institutional Review Board of Virginia Wesleyan University to examine student survey data from Spring 2020 to the end of the school year in June 2021. An evaluation of survey data will offer insight into student educational preferences (e.g., virtual, in-person). The work of CERTI will provide CBA with a foundation upon which to build technology options for our students, now and well into the future.



The mission of CERTI is to develop, evaluate, and disseminate new programs and practices utilizing innovative, student-centered technology in partnership with institutions of higher education and in collaboration with select member schools of the Virginia Association of Independent Schools.



### Capital Campaign

For over 30 years, Chesapeake Bay Academy has embraced the challenge of lifting students with learning differences to their highest potential. CBA is a dynamic and diverse school that transforms the lives of young people who thrive under its model of personalized, interactive, and project-based learning.

### Responding to a Changed Educational Landscape

From the first day of the stay-at-home order necessitated by COVID-19, the faculty of Chesapeake Bay Academy immediately transformed their classrooms. This took our students who are usually involved in hands-on instruction to virtual places of learning. Overnight they moved from using technology in the classroom to learning through technology at home.

Long before the virus changed everyone's lives, the Board and staff of Chesapeake Bay Academy developed a comprehensive strategy to advance the school in its mission: *To educate students through academic programs individualized to address their learning differences, empowering them with the skills and confidence necessary for success in higher education, careers and life.* 

Our priorities based on the current environment are:

- Upgrading technology to model leadership in the provision of online special education instruction.
- Addressing faculty needs for additional training and technical support.
- Upgrading our building to provide for blended learning environments, social distancing and safety for all.
- Ensuring as many children as possible who need a CBA education can receive one.
- Filling the gap for students with learning differences when other schools cannot provide for children with special needs in this new environment.

### Why I Give...

Harrison joined CBA in 3<sup>rd</sup> grade. He is now a Junior and over 6 feet tall! He has grown so much – intellectually, emotionally, and physically. There have been bumps along the way, but the CBA

faculty and staff have been there every step of the way to help Harrison and our family navigate school for our nontraditional learner.

In first grade
Harrison was
diagnosed with
ADHD (and later
ASD). By the end
of second grade,
it was clear that

traditional classroom learning was not working. What drew us to CBA were the small classes, low student/teacher ratio and their experience with children who learn differently. Harrison has thrived in the close-knit CBA community. "Little" things like anticipating when a student needs redirecting or needs a break are game changers.

The faculty and staff get to know the challenges and needs of individual students.

# **Because CBA Offers Non-Traditional Options**

CBA offers electives you may not find at traditional schools. Makerspace, Band and Culinary Arts have been some of Harrison's favorites. These classes teach valuable life skills. I love when Harrison comes home and asks to cook a healthy meal he had in class. He has become comfortable in the kitchen and most weeks cooks his own lunches.

CBA has also created spaces within the school to engage students including a beautiful stage to show off their talents, an outdoor classroom for fresh air and a sensory gym.

## Because CBA thoughtfully adapts to meet the needs of our community

I admire Dr. Jankowski's thoughtful leadership throughout the COVID-19 pandemic. Since March 2020, she has had to make many difficult decisions. The CBA faculty and staff have made the best of an unprecedented situation. I appreciate that every effort has been made to offer in-person learning as much as possible and that even now students have the flexibility to participate remotely. Although Harrison prefers to be in person there are days when he enjoys participating from home.

## Because CBA is committed to diversity, equity and inclusion

CBA supports families from across Hampton Roads. The students bring a variety of gifts and challenges. The teachers and staff work hard to accommodate a wide range of needs. They model the ideals of diversity, equity and inclusion, and in doing so teach our children to do the same. It is a very accepting environment and safe place for our children to learn and mature.

The CBA teachers and staff get to know the students in a way that most schools can't. Harrison trusts and respects them. When he needs to be corrected or redirected, they do it in a way that holds him accountable while teaching him how to anticipate and manage challenging situations. CBA provides him a safe space to learn social skills that can be hard for those with ADHD and ASD.

### Because the faculty and staff give so much

You can't put a price on knowing your child feels understood and respected at school. The teachers and staff have partnered with us every step of the way to guide Harrison through school while also teaching him how to be independent and contribute to the larger community. It's scary and overwhelming when your child struggles in a traditional school setting. I am so grateful we found CBA.

Individuals who are age 70 ½ or older can contribute up to \$100,000 from their IRA directly to a charity and avoid paying income taxes on the distribution. This is known as a qualified charitable distribution. It is limited to IRAs, and there are other exclusions and considerations. Please consult a tax advisor for guidance.

#### **Tax Credits**

CBA participates in the Neighborhood Assistance Tax Credit Program (NAP) and the Education Improvement Scholarships Tax Credit Program (EISTCP) through the Virginia Foundation for Learning Disabled Students (VFLDS). Gifts directed for the purpose of providing scholarships to low-income, learning-disabled students may be eligible for Virginia state tax credits up to 65%. CBA is pleased to offer this benefit to our donors, as credits are available. Please consult your tax adviser to determine your specific tax savings.
