CBA EARNS SIGNIFICANT SUPPORT

Early last June, Chesapeake Bay Academy welcomed a dynamic new member of our community. Dr. Shantanu Tilak, newly graduated Ph.D. candidate from Ohio State University, took on leadership of the Center for Educational Research and Technological Innovation (CERTI) at CBA. Dr. Tilak joined the community and immediately connected. He has provided professional development for our teachers, presented to the Board to share his upcoming research efforts, become a core member of the administrative team and become a student favorite as he seamlessly conducts his work in our makerspace and upper school mathematics classrooms.

My efforts with Dr. Tilak have involved cowriting grant applications to support the work of CERTI. Grant writing can sometimes be tedious work. That said, Dr. Tilak took it on with great energy. The process has provided us with a meaningful opportunity to focus our efforts and clearly articulate the vision of CERTI moving forward.

Unquestionably, the largest and most comprehensive of those grant applications was submitted to the Yass Foundation. With writing starting in late June and

submission in mid-July, we put the application to bed and moved on with the important work of launching the new school year. Imagine our surprise when we learned in mid-September that of 2,000 applications received for the Yass Prize, CBA had been selected as one of sixty-four quarterfinalist candidates!

Fast-forward to October, CBA was then announced as Semifinalists! At the time of publishing this report, CBA will receive \$200,000 and will also be considered for a finalist berth in mid-November, which has the potential to lead to even greater funding and recognition.

Dr. Tilak and the Yass Prize are both tremendous gifts to CBA that will continue to grow in the coming year. Who knows how things will develop - I can't say, but I know it will be exciting to watch. Stay tuned!



WHY WE SUPPORT: PARENTS SHARE THEIR SON'S STORY OF BELONGING

When you have a child who learns differently, the early years are often spent sitting through evaluations, assessments, and IEP meetings where the focus is placed squarely on deficits. We were those parents. We have reams and reams of documents comparing our son to baselines and graphs. And honestly, we

were weary with being told what didn't measure up. We knew Thomas had challenges, but we also knew in our heart of hearts, that he also had great potential. So was the challenge all his to conquer, or was it for us to find a key to unlock what we knew was there?

And the answer was both. We had always planned to keep Thomas in public school through fifth grade. Third grade had been somewhat of a struggle, he often came home shut down and exhausted - going into "cocoon mode," as we called it. We planned to attend a CBA open house in the summer of July 2022, knowing that CBA was a possibility for down the road. Open house turned into a private tour with and then a mad dash to get all of our application materials in so Thomas could begin his fourth grade year at CBA. That visit, and Thomas' two-day preview during the summer program (which turned into a week because he wanted to keep going) were all that it took. We knew CBA was where he needed to be.

Last September, when the first event of the year rolled around, the Fun Run, he actually asked to participate with his friends. As parents, this was mind-blowing to us on two fronts: first, because it was an outside-of-school-hours activity he asked to do; and second, because he wanted to participate with FRIENDS. The friendships that have grown amongst his classmates have been amazing to watch. And for us, the connections we have made with other parents have been so affirming – we, too, have a whole new tribe of friends.

Since that first school event, it has been

our pleasure to participate in the Annual Auction & Gala and Fund-A-Cause. Thomas' grandparents, all retired educators, have equally recognized the strides Thomas has made since coming to CBA, and have come on board to participate in Grandfriends Day and the CBA Golf Tournament. These are all events that we, as a family, plan to participate in for years to come. With each initiative to which we are able to contribute, we know our investment supports an extraordinary group of educators teaching a phenomenal group of students with a unique and tailored educational experience that can be found nowhere else.

It is difficult to put adequate words to what CBA means to our family. For the first time, Thomas is in a learning environment that plays to his strengths, makes common-sense accommodations and nurtures emerging skills each and every day. The teachers and staff have taken a child that was truly in academic and sensory survival mode, and brought out a student who loves learning, is willing to try new things and is finding hidden talents. Thomas eagerly jumps in the car at pick-up to tell us everything he did that day and what new things he learned. Gone are the days of "cocoon mode," our child has found his wings.

A DEIJ mission statement was created, revised, approved by the board, and posted on the school's website. Faculty implemented creative ways to incorporate diversity into the curriculum. Faculty and staff attended workshops, reviewed materials, held great discussions tackling difficult subjects, and bonded even more tightly as a group. DEIJ goals were incorporated into the five pillars of the strategic plan; results are evident in marketing materials, hiring decisions, the admissions process and more. DEIJ is embedded in the school's DNA.

I will admit, my job was made easier because neurodiversity is at CBA's foundation. It was not a stretch for faculty and staff to incorporate equity, inclusion and justice as the rest of the building blocks. CBA is truly a place where everyone belongs.

So why do we care? We care because belonging is critical to the success of our students. When a student feels that he/she/they belong, learning increases. Stress is minimized. Friendships are more genuine. Self-esteem rises. Conflicts decrease. When parents, caregivers, and families have a sense of belonging, students thrive academically, emotionally and socially. New adult friendships develop. Parental engagement increases. Community is strengthened. When faculty and staff have a sense of belonging, productivity rises. Retention increases. Recruiting the best becomes easier. Stress decreases. Creativity soars.

And when all of this is going on, others notice. This is what the Virginia Association of Independent Schools (VAIS) Accreditation Team had to say about the culture of belonging at CBA:

We actively stand against discrimination based on race, religion, gender, gender identity, sexual orientation, country of origin, and physical or cognitive differences. It is our intent that every individual who engages with CBA feels accepted, represented, and empowered to share their beliefs and opinions.

Students and families feel a strong sense of belonging as part of the CBA community. and express profound appreciation for their experience at the School. Parents passionately articulated that their children feel safe and nurtured at CBA; these students love the space they are in, and the faculty has rekindled their love of learning. Students are excited to come to school and parents expressed how CBA has benefited their own mental health by providing a refuge for families who have long fought the public school system or other independent schools for an educational program that fit the needs of their students. CBA has been a beacon of hope for these families and students.

Are we done? Nope. But we are off to a terrific start, thanks to the willingness of all involved to engage in the difficult and meaningful work. I am honored to be a part of the CBA family, to be trusted with educating, empowering and encouraging faculty and staff during this journey. I am so proud of the work that has been accomplished so far and excited about what is to come. We belong!



CERTI: NURTURING BELONGING THROUGH EDUCATIONAL RESEARCH AND PRACTICE

In a time where education has become a highly malleable experience, having been virtual and/or hybrid for the past few years, the role of technology in learning is one that needs to be investigated. Scholarship in educational technology has attempted to champion this cause. investigating how to create and evaluate the effectiveness of tools that increase individual knowledge uptake, and those that allow students to collaborate. The field has also made strides into understanding how students with learning differences interact with these tools. At Chesapeake Bay Academy, we have been committed to testing such models of technology-assisted classroom behavior and human-computer interaction; but specifically designed for neurodiverse learners. Our goal is to provide an emotionally and cognitively adaptive educational environment to our learners through a supportive educational community they can proudly say they belong to. We use technology in innovative ways here, and teachers at the school call themselves early adopters of many technologies.

Our teachers have used innovative tools such as customized e-books, interactive interfaces, telepresence robots, virtual reality, and making/tinkering technology, and have been stewards of implementing CBA's model of individualized learning. The introduction of Vibe Boards into our classrooms led to the creation of shared interfaces where every child, remote or in-



person, received egalitarian support to do their work. Remote peers were able to interact with the physical classroom through Kubi telepresence robots. With students returning in person, and the operationalization of a flexible upper school learning model, we have given our upper schoolers the ability to take ownership of how they learn. These fascinating phenomena all have one thing in common; they pivot technology to create a community of learners where everyone is appreciated; where everyone can tap into an individualized learning experience while not feeling like they live on an island.

With the establishment of the Center for Educational Research and Technology Innovation (CERTI), the school's research arm, we aim to not only study these naturalistic classroom environments at our school, but also make these efforts and curricula created by our teachers known to the wider public. Professional development efforts and targeted research grants are being designed and worked on to implement at CBA.

Through these efforts, we will make the experiences of neurodiverse students better understood to the larger scientific community, and laymen too. But what is the purpose? The primary focus of public schooling is focused inclusionary classrooms where students with learning differences are pulled out for bridging instruction. There needs to be an understanding of how one can create an environment where learning differences are not perceived as a deviation from the norm, rather just as a human difference that lets an individual tap into new forms of learning. Viewing educational environments as human and artificial or technological systems linked by cybernetic feedback loops may allow us to create a model to better understand these phenomena without our biases and expectations in the picture.

In working to better understand how teaching and learning at CBA works by applying a cybernetic approach to research, CERTI is creating partnerships between our students, teachers, researchers, and academics at local universities, and stakeholders across our community. The goal is to support programs of research and educational practice that help create inclusive educational environments with a cybernetic twist. I welcome you to join me in creating a dynamic lab devoted to pivoting the potential of technology to create high-variety educational environments where we all can belong.

QUALIFIED CHARITABLE DISTRIBUTIONS FROM IRA'S

Individuals who are age 70 ½ or older can contribute up to \$100,000 from their IRA directly to a charity and avoid paying income taxes on the distribution. This is known as a qualified charitable distribution. It is limited to IRAs, and there are other exclusions and considerations.

TAX CREDITS

CBA participates in the Neighborhood Assistance Tax Credit Program (NAP) and the Education Improvement Scholarships Tax Credit Program (EISTCP) through the Virginia Foundation for Learning Disabled Students (VFLDS). Gifts directed for the purpose of providing scholarships to lowincome, learning-disabled students may be eligible for Virginia state tax credits up to 65%.
